Re: "Katungul Funding 'never permanent" MORUYA EXAMINER

We refer to the attached newspaper where our elected Federal Member of Parliament for Eden-Monaro, Dr Mike Kelly AM MP stated "This has been the bane of my life".

Can you confirm Prime Minister that these are the views of Dr Mike Kelly or the views of the Australian Government and or the Labor Party?

We are again deeply offended by Dr Mike Kelly's ongoing comments in the media and as a result we have had to respond to the media after 5 years of in-action on a number of issues.

Dr Mike Kelly has never attended any of the Community Meetings that he has been invited to and has only met with Katungul on two occasions being once in his Electorate Office in 2007 for 1 hour. Nothing was addressed and no outcomes achieved. Then Dr Kelly finally came and met with us for 50 minutes when he came to Katungul Narooma Clinic in 2010 again no outcomes achieved.

The Katungul Aboriginal Medical Service is the only Aboriginal Community Controlled Health Service providing culturally appropriate health services from Ulladulla to the Victorian Border comprising 44 rural, remote and isolated Communities spread across 3 Local Government Areas which include the Shoalhaven City Council, Eurobodalla Shire Council and Bega Valley Shire Council with travelling distances of over 30,000 square kilometres. The Hon. Warren Snowdon was going to come and meet with us in January 2011 (copy attached) but the meeting was cancelled.

A 21-page joint evidence based funding submission was developed by Katungul and the South East NSW Division of General Practice dated 17 June 2008 (on our 15th Birthday) and was provided to Dr Mike Kelly.

The reality is we only receive enough funding to run one fulltime operational AMS and we are currently running 3 clinics in Bega, Narooma and Moruya. Last year we provided over 56,770 Episodes of Care and treated 8,694 patients. The cost of a fulltime Doctor is anywhere between \$390,000 and \$450,000 (depending on location and loadings, and insurances etc) and we currently have 2.3 FTE Doctors.

Our 2010/11 yearly funding from DoHA (OATSIH) is \$1,452,047 and we also receive \$252,907.28 for Katungul Bega Clinic. It should be noted that we receive no funding for Katungul AMS Moruya Clinic and the limited funding for Katungul Bega Clinic only allows 3 clinic days a week. We also receive no identified funding for Doctors.

Funding is only on a year to year basis (instead of on a 3 to 5 year recommended funding cycle applicable to other States and Territories) so it makes it extremely difficult to plan and employ on a yearly basis for Doctors, Aboriginal Health Workers, Dentists, Registered Nurses and Transport Drivers if we have no real commitment from one year to the next. In essence this is not justification for 'Closing the Gap" but only widening the gap of disparity.

Where is all the identified Government Aboriginal Health and Closing the Gap funding going?

We look forward to hearing from you Prime Minister Gillard.

Katungal funding 'never permanent'

THE Australian Governments Department of Health and Ageing has said that its funding of the Katungal Aboriginal Corporation Community and Medical Services was never meant to be permanent; and it will not be at fault if the Moruya clinic is forced to close:

It says Katungal CEO Damien Matcham is wrong in saying that the funding was meant to be ongoing.

"On December 7, 2007, the department provided a one-off amount of \$40,103 to assist with set-up and establishment costs of an outreach clinic in Moruya," a department spokesperson said.

"These funds were made available on the basis of advice from Katungul that they would be able to generate sufficient ongoing funds from Medicare-generated income, it is understood that this has not proved to be the case and Katungul has made a commercial ducision to continue operating the Moruya clinic by reducing services at its Narooma and Bega clinics.

"Katungul is provided with funds to provide health services to the communities on the Far South Coast of NSW. It is up to Katungul to determine how these funds are distributed amongst their three clinics."

Katungul has reduced services at both the Bega and Narooma clinics to divert resources to the Moruya clinic, and this is a

matter of concern to the department, which claims there should be enough to maintain the previous level of service.

"There has been no reduction in funding to Kattingul that would warrant any reduction in services."

Federal Member for Edon-Monaro Mike Kelly has had enough of the issue.

"This has been the bane of my life," he

"The department never promised the funding would be recurring; it has just been a misunderstanding."

Mr Matcham claims that Katungal was promised recurrent funding for staffing and operational costs for the Moruya clinic, but only received one-off funding for lease costs for 12 months and four computers.

Meanwhille more than 100 people turned up for the Katungal Moruya community meeting at Moruya Showground last Thursday to discuss the clinic's future.

"We are forming support groups to lobby the government to keep the service open," Katungal medical receptionist leante Pursons said.

Ms Parsons said many people were concerned that the closure of the clinic would leave a hig void in the community.

"Our statistics show we see between 180 and 250 clients per month," she said.

Another meeting is scheduled for April 18 at a venue to be decided.
