Dear Mr Clarke

I am writing to seek the Prime Minister's final approval for the Minister for Trade and Investment, the Hon Andrew Robb AO MP, to travel to the United States (Chicago, San Francisco, Washington and New York) and Cuba (Havana). It is proposed the Minister depart Australia on Monday 15 February and return on Saturday 27 February 2016.

The inaugural Australia United States Business Week (AUSBW) will take place over a ten day period from 16 to 26 February across six US cities (Boston, Chicago, Houston, Los Angeles, San Francisco and New York). AUSBW 2016 is the premier business-tobusiness component of the Australian Government's efforts to strengthen commercial ties with the United States. It is intended to drive investment momentum and give an international focus to Australia's new Innovation Agenda, announced by the Prime Minister in December. It is part of the expanded series of Australia Week trade missions and promotional events funded in the 2015-16 Budget, building on the success of the Australia Week events in China, India and Indonesia.

Mr Robb would lead a delegation of Australian companies from the agribusiness & foodscience, digital technology, medtech, resources & energy and tourism sectors in a programme of market briefings, investment roundtables, industry summits and site visits. Delegates would have the opportunity to engage with US research organisations, investors and multinationals with the objective of seeding ideas and creating opportunities for new business between Australia and the United States. The mission would catalyse and leverage existing relationships and look to seize new business opportunities, including those to be provided by the Trans Pacific Partnership Agreement.

It is proposed several Federal Ministers would lead individual stream programmes including Senator the Hon Mitch Fifield, Minister Assisting the Prime Minister for Digital Government (digitech stream); the Hon Sussan Ley, Minister for Health (medtech stream); Senator the Hon Richard Colbeck, Minister for Tourism and International Education (tourism stream); the Hon Josh Frydenberg, Minister for Resources, Energy and Northern Australia (resources and energy stream) and the Hon Wyatt Roy, Assistant Minister for Innovation (digitech and medtech streams). State and Territory ministers would also participate.

In addition to attending AUSBW, a visit to Washington by Mr Robb would provide a timely opportunity to build support for early US ratification of the Trans-Pacific Partnership Agreement, supporting the US Administration's efforts in this regard, while also advocating Australia's interests in this process.

Following his visit to the United States Mr Robb would lead a targeted business delegation to Havana, Cuba, in what would be the first visit by an Australian Trade Minister. The visit would comprise a series of meetings, business briefings and networking opportunities for Australian companies and the Cuban Government, including meetings with Cuba's leadership and nascent business community. The programme would serve to draw Cuba's attention to Australian expertise and comparative advantages, particularly in the agribusiness, infrastructure, resources, mining and skills/education sectors, and provide Australian businesses with an opportunity to develop a better understanding of the prospects and challenges of doing business in Cuba.

Given the breadth and length of the trip, Mr Robb has requested that he be accompanied by adequate staff to manage the needs of the business delegation of more than 200 in the United States, media engagements for himself and the delegation, a targeted business delegation in Cuba and a program in Washington to advocate for the Trans Pacific Partnership.

In this exceptional circumstance, he seeks permission to travel with three staff. ^{\$22} ^{\$22} would focus on speech and media requirements for the Minister and delegates and ^{\$22} and a would primarily focus on coordinating the business missions and delegates and the bilateral program of meetings and events in Washington.

I confirm that the most cost effective arrangements have been sought for the proposed travel. An itinerary, cost estimate and draft program for the proposed travel are attached.

The Hon Greg Hunt MP, Minister for the Environment, would be available to act as Minister for Trade and Investment from 15 to 27 February 2016 inclusive.

I would be grateful for your agreement to the proposed travel as set out above.

Dear Drew

I seek the Prime Minister's approval for The Hon Steven Ciobo MP to travel to the United States (San Francisco, Washington and New York) from Thursday, 18 February to Saturday, 26 February 2016.

The visit would be Mr Ciobo's first in his capacity as Minister for Trade and Investment following his anticipated swearing in on Thursday, 18 February. The visit provides a timely opportunity to engage interlocutors in the United States, Australia's largest direct investor. The visit would coincide with the inaugural Australia United States Business Week (AUSBW) which will take place across six cities from 16 to 26 February. AUSBW is the premier business-to-business component of the Australian Government's efforts to strengthen commercial ties with the United States. It is intended to drive investment momentum and give an international focus to Australia's new Innovation Agenda, announced by the Prime Minister in December. AUSBW will build on the success of similar Australia Week events in China, India and Indonesia.

Meetings with United States officials in Washington DC would allow Mr Ciobo to build support for early US ratification of the Trans-Pacific Partnership Agreement, supporting the US Administration's efforts in this regard, while also advocating Australia's interests in this process.

In San Francisco, Mr Ciobo would launch the San Francisco Landing Pad, the first element of the Global Innovation Strategy of the National Innovation and Science Agenda. Mr Ciobo would deliver a keynote address at a networking dinner involving Australian AUSBW delegates and 200 US business executives. Mr Ciobo would also join a breakfast with US and Australian CEOs and host AUSBW delegates on a site visit to the GE Software Centre to discuss potential reinvestment in Australia.

In New York, Mr Ciobo would participate in two investor roundtables and meet banking executives and major potential investors in Australia. Following consultations with the Hon Julie Bishop, Minister for Foreign and Affairs, and Senator Concetta Fierravanti-Wells, Mr Ciobo proposes to fulfil some of his commitment made as Minister for International Affairs and the Pacific to represent Australia at the United Nations Development Programme (UNDP) 50th Anniversary Ministerial Event.

Mr Ciobo's draft program indicates those elements of this program that are proposed to be shared with the Special Envoy for Trade, the Hon Andrew Robb AO MP.

It is proposed Mr Ciobo be accompanied by myself and s22 and s


