# FOI Request – Documents

1. Number of outcome payments paid to providers by outcome type (e.g. 13 week full, 13 week partial, education) in each quarter (or month if that is more practical) from 1 July 2013 to 1 September 2017.

#### Response:

The table below shows the outcome payments paid to providers by outcome type, quarterly from 1 July 2013 to 31 August 2017. Note that some outcome types are not relevant under the CDP – including education outcomes, participation outcomes and 7 week employment outcomes.

Full employment outcomes are achieved when a job seeker's dependence on income support is fully reduced for the defined time period, or the job seeker is fully meeting their Mutual Obligation Requirements through employment. Partial outcomes are achieved where there is a significant and partial reduction in a job seeker's dependence on income support or the job seeker is significantly and partially meeting their Mutual Obligation Requirements through employment.
