**CORONAVIRUS UPDATE** 

The National Cabinet for Australia's Coronavirus Response:

- 1. Noted the oral update by the Prime Minister on the more positive health and economic data from the last week, including the generally positive response to the Commonwealth's JobKeeper package.
- 2. Noted the oral update by the Chief Medical Officer (CMO) on:
  - (a) the latest epidemiological data
  - (b) availability of testing kits and personal protective equipment (PPE)
  - (c) work under way by the Australian Health Protection Principal Committee (AHPPC) to inform future National Cabinet discussions on changes to baseline restrictions and other measures.
- 3. Noted the updated theoretical modelling of health system capacity to address COVID-19, including the accompanying glossy publication, PowerPoint presentation and two academic manuscripts.
- 4. Agreed to:
  - (a) the public release of the glossy publication and PowerPoint presentation on modelling, once adjusted to clarify messaging as discussed by National Cabinet.
  - (b) publication of the two academic manuscripts on modelling on 7 April 2020.
- 5. Noted modelling based on Australian data is currently being developed and will be provided to National Cabinet before the end of April 2020.

- 6. Agreed the Prime Minister will return to National Cabinet after Easter with an update on the COVID-19 contract tracing application currently being developed by the Commonwealth.
- 7. Noted and agreed to publicly release the following AHPPC statements:
  - (a) Off-label Medicines for Treatment and Prophylaxis of COVID-19
  - (b) Healthcare Worker use of PPE when Caring for Suspected or Confirmed COVID-19 Patients
  - (c) Home Isolation
  - (d) Organ Donation and Transplantation during the COVID-19 Pandemic
  - (e) Rapid Point of Care Lateral Flow Devices to Detect Antibodies to SARS-COVID-2.
- 8. Agreed that States and Territories would implement the Mandatory Code of Conduct for commercial tenancies (as amended) via legislation or regulation, as appropriate, with:
  - (a) a date of effect of 1 April 2020
  - (b) the Commonwealth to work with the Northern Territory on bespoke arrangements for implementation.
- 9. Agreed that residential tenancies are an issue for the States and Territories and would be progressed through the Board of Treasurers.
- 10. Noted the previously agreed AHPPC recommendation on quarantine and self-isolation for maritime crew and agreed to consider, at the next meeting, a draft uniform exemption for non-cruise maritime crew and guidelines for enforcement, including the role of the Australian Border Force.
- 11. Noted the oral update by the Prime Minister on the development of consumer hardship provisions for the energy and water sectors and agreed to consider the draft Principles for Hardship Provisions prepared by the Commonwealth and the energy sector paper prepared by the Commonwealth Minister for Energy and Emissions Reduction at the next meeting.
- 12. Noted the advice from the Prime Minister that the JobKeeper package is not available to childcare centres operated by local councils.

13. Noted the points raised by individual jurisdictions in relation to regional airports, cruise ships, overseas travel by Australians and streamlining of Ministerial Council discussions.

**CORONAVIRUS UPDATE** 

The National Cabinet for Australia's Coronavirus Response:

#### 1. Noted:

- (a) the oral update by the Prime Minister on the passage of the JobKeeper legislation and the importance of all jurisdictions working on implementation of agreed COVID-19 measures and supports
- (b) the Commonwealth Treasury is preparing further economic modelling and exploring options to lift economic activity in critical sectors for future consideration by the National Cabinet, and that the Treasury Secretary will brief the next meeting
- (c) the importance of lifting economic activity without increasing health risks, and that jurisdictions will begin to consider ways to achieve this, particularly businesses adjusting operating models and governments removing regulatory obstacles to enable a 'COVID economy' over the coming six weeks
- (d) the oral update by the Commonwealth Chief Medical Officer (CMO) on the latest epidemiological data on COVID-19
- (e) the CMO will bring advice from the Australian Health Protection Principal Committee (AHPPC) on the strategic framework to guide next steps for managing restrictions and health system responses to the next meeting.

- 2. Agreed the AHPPC recommendations on the management of health risks for Australian crew on international flights, including the new requirement that Australian crew self-isolate at their place of residence (or hotel if not in their local city) between flights or for 14 days, whichever is shorter.
- 3. Agreed to implement a class exemption for non-cruise maritime crew and the other proposed actions (SM20/0414 of 9 April 2020 refers), including a new action to 'Note States and Territories may adopt additional protocols, in consultation with industry, that create protections for crews on-board vessels'.

### 4. Noted:

- (a) the AHPPC advice that, post the 14-day mandatory quarantine period for returned international travellers, it is not necessary for travellers to undertake another 14 days in another State
- (b) relevant jurisdictions did not agree to change existing jurisdictional requirements for returned overseas travellers to serve an additional quarantine period following interstate transit.
- 5. Agreed the Prime Minister, working with the Commonwealth Minister for Health, provide advice to States and Territories on proposed minimum allocations of medical supplies to jurisdictions from the National Medical Stockpile.
- 6. Noted the AHPPC Guidance for Making Schools a Safe Environment and the National Principles for School Education agreed by Education Ministers.
- 7. Agreed that in relation to the guidance and national principles outlined in paragraph 6 above:
  - (a) the two documents be combined, simplified and strengthened with more detail
  - (b) this work be undertaken by New South Wales, Western Australia and the Commonwealth (the Minister for Education and the CMO)
  - (c) the Commonwealth Minister for Education will consult representatives from the Catholic and Independent Schools sectors on these documents with the aim of having a consistent approach across the education system
  - (d) the revised document be discussed at the next National Cabinet meeting.
- 8. Noted that the Commonwealth Minister for Education is working with education experts on the potential impact on educational outcomes of the different learning arrangements that have been put in place in response to COVID-19.

- 9. Agreed to adopt the nationally consistent principles for support for households and small businesses facing hardship in paying for essential services.
- 10. Agreed the implementation of visa arrangements in the agricultural sector (SM20/0415 of 9 April 2020 refers) with:
  - (a) the States and Territories responsible for ensuring accommodation complies with self-isolation and social distancing requirements, in conjunction with local governments and the National Farmers Federation
  - (b) the Australian Government and States and Territories to undertake best efforts to have arrangements in place by 17 April 2020, or as soon as practicable thereafter.
- 11. Noted the Prime Minister will investigate the option of a national permit system for the movement of Working Holiday Maker visa holders and return with advice to the National Cabinet.
- 12. Agreed a presentation on fuel and energy security will be provided at a future meeting.
- 13. Agreed to hold the next meeting of the National Cabinet at 10am on Thursday 16 April 2020.

**CORONAVIRUS UPDATE** 

The National Cabinet for Australia's Coronavirus response:

- 1. Noted the oral update by the Prime Minister on:
  - (a) Virgin Australia and the Commonwealth's intention to issue a strong statement on the importance of having two viable commercial airlines in Australia
  - (b) the need for the sharing amongst jurisdictions of crime data to support future COVID-19 response planning
  - (c) additional arrangements being put in place by the Australian Border Force to support States and Territories manage the arrivals of Australians returning on charter flights
  - (d) the decision by the Commonwealth, based on the latest Australian Health Protection Principal Committee (AHPPC) advice, to extend the current travel restrictions for a further four weeks from 22 April 2020, with a review at the conclusion of that four-week period
  - (e) preliminary JobKeeper registration data which will be presented to the National Cabinet at the next meeting, noting that registrations commenced today.

- 2. Noted the oral update by the Chief Medical Officer (CMO) on the latest epidemiological data on COVID-19 and the significant expansion in testing under way in jurisdictions.
- 3. Noted the work under way within the Commonwealth to identify potential Australian Defence Force (ADF) support to States and Territories for localised responses to outbreaks, and the agreement of Queensland and Tasmania to work with the ADF to identify practical issues and options for such support for future National Cabinet consideration.
- 4. Agreed to further declaratory advice that the one person per four square metre rule does not apply in school classrooms, with all schools to consult the most recent AHPPC advice issued on 16 April 2020.
- 5. Agreed to adopt the AHPPC principles for initial restoration of elective surgery, with:
  - (a) this to be done as a gradual restart, subject to capacity constraints and local circumstances
  - (b) initial relaxation to begin from Monday 27 April 2020 with a review of arrangements in two weeks
  - (c) the proposed approach of re-opening one in four theatre and endoscopy lists but with some flexibility and no specific cap placed on the quantity of eligible services and procedures to be undertaken
  - (d) no cosmetic surgery to be provided
  - (e) the restart to include all Category Two and equivalent procedures in the public and private hospital sectors and selected Category Three and other procedures including:
    - (i) IVF
    - (ii) screening programs (cancer, including breast cancer, and other diseases)
    - (iii) post cancer reconstruction procedures
    - (iv) procedures for children under 18 years of age
    - (v) joint replacements (including knees, hips and shoulders)
    - (vi) cataracts and eye procedures
    - (vii) endoscopy and colonoscopy procedures
  - (f) dentists to move to Level Two restrictions.

### 6. Noted:

- (a) the up-to-date data on the stock of personal protective equipment (PPE) in the National Medical Stockpile (NMS)
- (b) the initial advance allocation of masks from the NMS for each jurisdiction to be dispatched by 31 May
- (c) the conditions on which these masks will be allocated
- (d) that any further distributions will likewise be calculated in accordance with need.
- 7. Noted the oral update by the Acting Secretary of the Department of Health, the Chief Information Officer of the Department of Health, and the Chief Executive Officer of the Digital Transformation Agency on the new application (the 'App') under development by the Commonwealth to support COVID-19 contact tracing by State and Territory health officials.

The National Cabinet for Australia's Coronavirus response:

- 1. Expressed sincere condolences to the families and friends of the four Victorian Police Officers killed this week in the line of duty, as well as to the entire police family, sworn and unsworn, across the nation.
- 2. Noted the oral update by the Prime Minister on the finalisation of the COVID-19 Contact Tracing App and the commitment of the Commonwealth to provide further briefings to State and Territory officials on the communications campaign to promote the use of the App.
- 3. Noted the oral update by the Chief Medical Office (CMO) on the latest epidemiological data on COVID-19, the substantial nation-wide expansion in testing and the planned cessation of use of the isolation declaration cards in light of compulsory hotel-based quarantine arrangements.
- 4. Noted the Australian Health Protection Principal Committee (AHPPC) statements on:
  - (a) the use of personal protective equipment in patients with COVID-19
  - (b) the recommencement of kidney transplantations.

- 5. Noted the AHPPC statement that, in the current Australian context of relatively low community transmission, the use of masks by Australians is not warranted and agreed on the importance of clear community messaging on this issue.
- 6. Agreed to the development, by the AHPPC, of national principles to guide future State and Territory decisions on re-commencement of:
  - (a) professional/elite sports
- (b) community sport and recreation activities with the principles to be brought to National Cabinet for consideration.
- 7. Noted the updated COVID-19 modelling and agreed to:
  - (a) the public release of the modelling, including the associated presentation
  - (b) the weekly publication of updates on Reff and symptomatic case detection data.
- 8. Noted the draft Pandemic Intelligence Plan and draft Australian National Disease Surveillance Plan and agreed to:
  - (a) consider the final draft plans at the next meeting
  - (b) discuss progress on meeting the precedent conditions for relaxation of baseline measures.
- 9. Noted the current and future planned actions by jurisdictions to relax social distancing and other measures that were above the nationally-agreed baseline.
- 10. Agreed to discuss the draft AHPPC advice on the list of baseline measures for potential future relaxation at a future meeting, which will take into account health, economic and social factors.
- 11. Noted the oral update by the CMO on the allocation of ventilators and that no pre-distribution of ventilators is proposed.
- 12. Noted the current and planned future arrangements for schooling in each jurisdiction and agreed to:
  - (a) the publication of the AHPCC statement confirming that smaller class sizes might reduce the risk of COVID-19 transmission in schools

- (b) the one person per four square metre rule and the 1.5 metre distance rule are not appropriate or practical in classrooms or school corridors.
- 13. Noted the Commonwealth would provide jurisdictions with a copy of the recently completed report by Vice Chancellor of the University of Tasmania, Professor Rufus Black, on the impact of COVID-19 schooling arrangements on educational outcomes.
- 14. Agreed that the AHPPC would be asked to provide further advice in relation to the management of COVID-19 in boarding schools.
- 15. Noted that some aged care facilities were continuing to apply complete lockdowns or bans on visits of carers and families and that the Commonwealth Government will:
  - (a) continue to monitor the steps Residential Aged Care Facilities are taking
  - (b) if necessary, move to require facilities to seek an exemption from the Aged Care Quality and Safety Commission before implementing additional restrictions.
- 16. Agreed to the National COVID-19 Safe Workplace Principles, which will underpin nationally-consistent, industry-specific work health and safety guidance on COVID-19 that will be provided via a central hub on the Safe Work Australia website.
- 17. Noted the paper on current numbers for JobKeeper registrations, early access to superannuation, Boosting Cashflow for Employers and the \$750 cash payment.
- 18. Noted the update on the implementation of new agricultural visa conditions.
- 19. Noted the Commonwealth would continue to work closely with States and Territories on the implementation of small infrastructure projects, including through flexibility on funding profiles.
- 20. Agreed to the National Suicide Prevention Adviser, Ms Christine Morgan, undertaking a stocktake of mental health issues and Government responses across jurisdictions and presenting her findings to the National Cabinet.
- 21. Noted the experiences to date of jurisdictions in relation to health and other outcomes for their indigenous communities.

- 22. Agreed to hold the next meeting at 10am Friday 1 May 2020 and to include on the agenda:
  - (a) weekly update on the COVID-19 modelling
  - (b) Pandemic Health Intelligence Plan and Australian National Disease Surveillance Plan
  - (c) draft National Principles to guide the recommencement of professional/elite sports
  - (d) a further economic briefing (including on revenue lines and the role of Northern Australia Infrastructure Facility in economic recovery) from the Secretary of the Commonwealth Department of the Treasury
  - (e) opportunities for international education
  - (f) infrastructure and construction industry current challenges and future opportunities.

The National Cabinet for Australia's Coronavirus response:

- 1. Noted the oral update by the Prime Minister on additional funding for the aged care sector to assist further with the costs associated with providing care in a COVID-19 environment.
- 2. Noted the oral update by the Secretary of the Commonwealth Department of the Treasury on the global and Australian economic situation, forthcoming negative economic data, and the importance of boosting consumer and business confidence, including through the actions and announcements of the National Cabinet.

### 3. Noted:

- (a) the oral update by the Chief Medical Officer (CMO) on the latest epidemiological data on COVID-19
- (b) the updated COVID-19 modelling, including that there is increased sensitivity and margin for error in the Reff measure now case numbers are lower
- (c) the oral update by the CMO on the development of real-time heat maps of Intensive Care Unit (ICU) capacity (the ANZICS ICU heat maps) and his proposal to provide a live presentation on the ANZICS ICU heat maps to the National Cabinet.

- 4. Noted the oral update by the Chief Executive Officer of the National Mental Health Commission (NMHC) on mental health and wellbeing issues in the context of the pandemic and the proposed National Pandemic Mental Health Plan.
- 5. Requested that the National Pandemic Mental Health Plan be finalised by 8 May for consideration by the National Cabinet.
- 6. Endorsed the COVID-19 Pandemic Health Intelligence Plan and the Australian National Disease Surveillance Plan.

### 7. Noted:

- (a) the good progress against the precedent conditions as outlined in Appendix 1 of the Pandemic Health Intelligence Plan
- (b) the need for further action on surveillance (testing), resources to support surveillance, uptake and use of the COVIDSafe App, and stocks of gowns and goggles
- (c) the need for the status of the precedent conditions to be continuously updated.
- 8. Noted the oral update by the Prime Minister on the COVIDSafe App and the associated communications activities.
- 9. Agreed the importance of all National Cabinet members making the uptake of the COVIDSafe App a prominent feature of their public messaging, public communication campaigns, and messaging to their State or Territory employees.
- 10. Endorsed the National Framework for Addressing Localised Outbreaks of COVID-19.
- 11. Noted the matrix of current COVID-19 restriction measures enacted by States and Territories.
- 12. Agreed to meet on 5 May to commence consideration of the potential easing of restrictions, taking into account health, economic and social factors, with the aim of agreeing appropriate easing of restrictions on 8 May.
- 13. Noted jurisdictional views on the role of state border controls as part of an overall approach to easing restrictions and managing COVID-19 transmission.
- 14. Noted the oral update by the Prime Minister on discussions with New Zealand on the potential for a Trans-Tasman travel arrangement, and agreed to invite the New Zealand Prime Minister to participate in a COVID-19 discussion at a future National Cabinet meeting.

- 15. Agreed to the National Principles for the Resumption of Sport and Recreation Activity with the following amendments, noting that implementation will be according to jurisdictional circumstances:
  - (a) Principle 5 first sentence now to read "The Australian Institute of Sport 'Framework for Rebooting Sport in a COVID-19 environment provides a guide for the reintroduction of sport and recreation in Australia, including high performance sport"
  - (b) Principle 7 remove final sentence
  - (c) Principle 9 delete in full.
- 16. Agreed the Australian Institute of Sport Framework for Rebooting Sport in a COVID-19 Environment.
- 17. Noted the advice from Victoria, NSW, Western Australia and Queensland on a proposed framework for resuming national NRL and AFL competitions.

- (a) to request the Australian Health Protection Principal Committee (AHPPC) develop further advice for the NRL, AFL and other major codes as requested, on the core requirements and parameters of any competition model, to inform any revision or refinement of the code's proposal
- (b) any revised proposal will need the support of all 'host' jurisdictions.
- 19. Agreed the draft Code of Conduct on Pandemic Procedures for Residential Aged Care.
- 20. Agreed the AHPPC statement on Risk Management for Re-opening Boarding Schools and Schools-based Residential Colleges.
- 21. Agreed Justice Sector Preparedness and Managing COVID-19 in Corrections Facilities will be considered at the next National Cabinet meeting.

- 22. Agreed the Prime Minister return to the next meeting of the National Cabinet with the latest advice on the number of Australians still seeking repatriation and the arrangements in place through the National Coordination Mechanism for managing future incoming flights, including charter flights.
- 23. Agreed to meet on 5 May and 8 May to consider easing of restrictions with the relevant papers to be provided to National Cabinet members by 5pm on 4 May and 10am on 7 May.

### The National Cabinet:

1. Noted the oral update and placemat provided by the Prime Minister on the Future of National Cabinet and reformed arrangements for the architecture of Federal-State relations.

- (a) National Cabinet has made an important contribution to minimising the health and economic impacts of COVID-19 and will continue to pursue reforms in the national interest beyond the pandemic
- (b) National Cabinet's agenda will remain confined to a limited number of issues at any one time to enable it to maintain focus and purpose
- (c) the initial focus of National Cabinet will be job creation as the economy emerges from the COVID-19 pandemic
- (d) National Cabinet will be able to establish and task National Cabinet Reform Committees to progress priority reform issues and those Committees will:
  - (i) be led by a Commonwealth representative
  - (ii) report directly to the National Cabinet
- (e) National Cabinet will continue to engage directly with experts relevant to the issue being considered, including existing Expert Advisory Groups such as the Australian Health Protection Principal Committee and Heads of Treasuries and additional groups as appropriate

- (f) National Cabinet will continue as a Federal Cabinet Office Policy Committee operating under Cabinet rules, with National Cabinet Reform Committees also operating under Cabinet rules
- (g) the Council on Federal Financial Relations (CFFR) will report to National Cabinet and will:
  - (i) operate under Cabinet rules
  - (ii) take responsibility for managing all Federal-State funding agreements, including National Partnership Agreements (NPAs)
  - (iii) initiate a review of all NPAs with the intent of rationalising and decreasing the number of Agreements
- (h) National Cabinet, together with CFFR and the Australian Local Government Association, will constitute the National Federation Reform Council (the Council), which will:
  - (i) meet annually face-to-face
  - (ii) be able to establish Taskforces to support the Council on priority national federation issues, such as Closing the Gap and Women's Safety
- (i) existing Ministerial Forums and Ministerial Regulatory Councils will be reviewed and rationalised and, if retained, will be expected to resolve issues themselves and not have a direct connection with the National Cabinet
- (j) all NPAs will be transferred to CFFR for management and future funding arrangements attached to issues addressed by Ministerial Forums and Regulatory Councils will be negotiated with and by CFFR
- (k) National Cabinet will:
  - (i) continue to meet every two weeks while it manages the impacts of COVID-19
  - (ii) shift to monthly meetings at an appropriate time
  - (iii) continue to meet via telepresence with at least one face-to-face National Cabinet meeting a year
  - (iv) retain discretion to vary these arrangements as required

- (1) to consider further:
  - (i) the number, focus and terms of reference of the National Cabinet Reform Committees referred to in paragraph 2(d) above
  - (ii) the reset of the Ministerial Forums and Ministerial Regulatory Councils referred to in paragraph 2(i) above
  - (iii) the National Federation Reform Council and related Taskforces.
