
I, QUENTIN BRYCE, Governor-General of the Commonwealth of Australia, acting

Determinations.




*Australian Bureau of Statistics Act 1975*Termination of Appointment and Appointment of Persons to Act in the Office of







- Mr Bernard Riordan to be a full-time Commissioner of Fair Work Australia from 26 March 2012 until each attains the age of 65 years.



Safety, Rehabilitation and Compensation Commission


