In the absence of having a Minister, I just wanted to let you know that the Clean Energy Regulator is undertaking some routine actions today which relate to the provisional surrender process which has just ended. Aspects of this may give rise to sensitivities, which the PM or Tsr may be asked about, as the Regulator will publish the identities of entities in shortfall.

The Clean Energy Regulator is updating the Liable Entities Publications Database (LEPID) today to include information about 4 entities that are in shortfall (two entities have not met any of their respective liabilities; Section 22 and two have made only partial surrenders; Section 22 (controlled by Mr Clive Palmer)). Section 22

Information about the 254 entities that met their full carbon price liabilities was included in the LEPID on 21 June 2013.
