Good morning all,

The Attorney General's Department is coordinating the Commonwealth's participation in the Royal Commission into the Protection and Detention of Children in the Northern Territory (NTRC) and has requested PM&C's input to a whole of government brief on the Change the Record (CtR) report (May 2015) "Review of the Implementation of the Royal Commission into Aboriginal Deaths in Custody (RCIADIC)".

The NT RC Taskforce in IAG's Community Safety Branch is coordinating the PM&C response to this request, and is seeking input from all relevant IAG divisions. While detailed in its approach, as a desktop audit, the Change the Record Report lacked input from government. As such, this is an opportunity to correct their assessment of the Commonwealth's implementation of recommendations, as appropriate. In most cases, the policy context has moved on considerably since the RCIADIC recommendations were released 25 years ago.

To keep this request to a manageable task, the NTRC Taskforce has analysed the CtR report and excluded those that present no concern for the Commonwealth.

The remaining recommendations have been allocated to the IAG division likely to have, if not primary responsibility for the relevant policy framework, at least awareness of the information necessary to address issues raised for the Cth.
