
National Careers Ambassador

Key Points

- Scott Cam was announced as the National Careers Ambassador on 10 October 2019.
- The Ambassador will champion the work of the National Careers Institute.
- The Ambassador will help the Institute to deliver consistent information about career pathways in collaboration with:
 - o government,
 - o industry,
 - o schools, and
 - o employers
- The Ambassador will also assist the Institute in raising the profile of vocational education and training as a valuable and rewarding choice.



If asked: What has Mr Cam done since being appointed?

- The role of the Ambassador is to raise awareness of careers education and information, promote career pathways, particularly VET pathways, and promote the initiatives of the National Careers Institute.
- Since being appointed, he has reached Australians through attending events (in person and by featuring in videos) and publishing social media posts, for instance.
- Further questions should be directed to the Department of Education, Skills and Employment.

If asked: What will Mr Cam do over 2020?

- Mr Cam will undertake a range of activities in 2020, including:
 - o events e.g. attend National Careers Week,
 - stakeholder engagement activities e.g. through the National Careers Institute's e-hub,
 - o engagement through social media channels,
 - o featuring in digital materials such as videos, and
 - o collaborating with the Institute to shape its future.

If asked: How much is Mr Cam being paid?

- Mr Cam will be paid \$350,000 for this role.
 - (This consists of \$262,500 (ex GST) in 2019–20 and \$87,500 (ex GST) in 2020–21).

The Australian Government established the National Careers Ambassador role to promote career development and the diversity of skills and qualifications that can be achieved with vocational education and training (VET) qualifications.

The Government appointed Mr Cam as the inaugural National Careers Ambassador, as he is a former apprentice and is a real-life example of where vocational training can take you.

As well as being a well-known and respected Australian, he is also a qualified tradesman who runs his own business and has employed apprentices in his business. Mr Cam has promoted jobs and apprenticeships for both Labor and Coalition Governments.

Mr Cam has already brought greater profile to the Government's investment in the National Careers Institute by engaging online and through his social media profile. He has recently kicked off a national tour where Mr Cam will attend events across Australia, including regional locations, during 2020.

Mr Cam will use those events to promote career opportunities and highlight ways to access the many career pathways on offer.

He will play a key role highlighting how VET is best positioned to address the future skills needs of Australia's employers and provide a successful career path for students and job seekers.


