The Taskforce has been working tirelessly around the clock. 

PM&C will lead a whole-of-government effort with the assistance of secondees from other agencies to cover two lines of action:

Examining the content of the Wikileak data:

- rapidly obtain copies of information published to the wikileaks website
 pertinent to Australia's national security, intelligence, foreign policy and
 diplomatic interests (as guided by search terms provided by line agencies),
