- Compulsory quarantining of all returning travellers
- Quarantine to occur in hotels at the port of arrival
- This would be done on a reciprocal arrangement
- To be implemented and enforced using State and Territory powers
- Move to implement as soon as possible but before midnight Saturday 28th
- Commonwealth to provide ABF and ADF support – bespoke arrangements based on need will be negotiated with each jurisdiction.
