

Good afternoon

OPC is currently arranging an internal review of an FOI decision in relation to an amendment to the Humanitarian Overseas Service Medal Declaration in 2012. OPC's decision to refuse access to documents was based on the s42(1) exemption for documents which would protected by legal professional privilege.

In 47F request for review, 47F asserts that AusAid (DFaT) provided 47F with a copy of the draft declaration and that this would imply a waiver of legal privilege. The Department of Foreign Affairs and Trade has advised that they do not waive legal professional privilege in this matter but also indicated that the Department of Prime Minister and Cabinet administers the Humanitarian Overseas Service Medal and may have some interest in this FOI request.



I'd be grateful if OPC can review their decision not to disclose the documents I seek, cited in decision letter c19/77 attached.

I respectfully contend the section 42(1) exemption doesn't appear to apply in this case as AusAID disclosed the proposed amendment of humanitarian overseas service medal (iraq) declaration 2004 to extend to specified commercial contractors to me in March 2012. AusAID apparently waived the legal professional privilege after engaging in conduct that is inconsistent with the maintenance of that privilege.
