Oral Update SM20/0801 ENVIRONMENTAL

PROTECTION AND BIODIVERSITY CONSERVATION ACT

The National Cabinet:

- 1. Considered the oral update by the Prime Minister on the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act).
- 2. Agreed in principle to adopt reforms to the EPBC Act approval process to move towards a single-touch approach, with the Commonwealth Government to enter into bilateral approval agreements with States and Territories.
- 3. Noted the 15 major projects which will be fast-tracked under bilateral agreements between the Commonwealth Government and States and Territories.
- 4. Noted national standards for environmental approvals will be developed simultaneously through further public consultation.

- Note that the National Cabinet has previously tasked Infrastructure and Transport Reform Committee with expediting major projects through approvals processes, building on actions governments have already taken such as:
 - a. the Australian Government applying additional resources to accelerate the 15 major projects endorsed by National Cabinet on 24 July 2020 through Commonwealth environmental assessment processes; and
 - b. state and territory governments fast-tracking pre-construction planning and assessment processes for priority infrastructure projects.

2.17	It is also important that wherever possible we partner and prioritise to expedite processes where we can. For example, the agreement earlier this year to expedite environmental approvals at the Commonwealth and state/territory level for 15 major projects is a significant step forward. Where multiple approvals are required for a project, looking for opportunities for these to occur in parallel can help reduce the lead times for projects. By partnering where possible we can ensure that key projects are delivered as quickly as possible.
2.18	Through the June 2020 meeting of the former Council of Australian Government Transport and Infrastructure Council, ministers committed to a streamlining reform agenda that included the Australian Government reviewing the threshold of Australian Government funding that triggers the requirement for a project proponent to submit a business case to Infrastructure Australia as a prerequisite to accessing Australian Government funding under the Infrastructure Investment Program. The Deputy Prime Minister has requested states provide their views on an appropriate threshold. The Australian Government welcomes views of states and territories as soon as practicable. Senior officials are preparing advice for Infrastructure and Transport Ministerial Meeting to consider in the new year.
