# Ms Danielle Roche OAM

- 1. Ms Roche has been a part-time Chairperson of the NADC Board since 25 July 2017 and her current term expires on 31 March 2021. You have indicated that you wish to extend Ms Roche as Chairperson for three months, until 30 June 2021.
  - a. As Minister, you may extend the term of an appointee once for a period of up to three months without consulting the Prime Minister, or the Cabinet.

## National Australia Day Council Board review

- 2. The NADC Constitution requires a minimum of five directors and the usual practice has been to have ten directors appointed to the Board.
  - a. Major General Maurie McNarm AO (Ret'd) wrote to you on 9 February 2021 notifying you that he would not seek reappointment as Director on the Board of the NADC when his term expires on 31 March 2021 (Attachment E).
  - b. The current board membership is at Attachment D.
- 3. In the context of considering future appointments to the Board, you requested a review to be undertaken into the operations and composition of the Board, to ensure the Board is equipped with relevant skills and expertise to successfully deliver the annual Australian of

the Year Awards and to continue to lead the evolving way Australia's national day is celebrated.

- 4. We are in the process of engaging Ms Glenys Beauchamp PSM to undertake this review, and anticipate it will be completed by 23 April 2021.
  - a. Ms Beauchamp is a former Departmental Secretary and is currently serving on three Government Boards. She has extensive experience working with Government agencies and is well-placed to provide expert advice.

- 6. NADC is a Commonwealth company subject to the reporting and accountability requirements in Chapter 3 of the *Public Governance, Perofirmance and Accountability Act 2013* and limited by guarantee under the *Corporations Act 2001*. The operations of NADC are overseen by a Board of Directors.
- 7. Following the Prime Minister's or Cabinet's endorsement, appointments to the NADC Board are made by you as the responsible Minister, under Rule 6.1 of the Constitution of the NADC.

- 1. On 16 April 2021, the Department of the Prime Minister and Cabinet (PM&C) commissioned Ms Glenys Beauchamp PSM (Proximity consultants), to conduct a Review of the Composition and Operations of the National Australia Day Council (NADC) Board.
- 2. We received the final report of the Review from Ms Beauchamp on 18 June 2021.
  - a. A copy of the Review report is attached for your information.
