

#### **Recent projects:**

 On July 12 2022, Worley was awarded a Santos professional services contract to help guide its Bayu-Undan carbon capture and storage project in the Timor Sea. The project is expected to store up to 10 million tonnes of carbon dioxide per annum, and has the potential to be one of the largest CCS projects in the world. s 47C, s 47E(d)

• In 2019-2020 Worley worked with Queensland Nitrates and Neoen to complete a feasibility study for a new green hydrogen to ammonia plant. The study determined that the project is technically viable, but it requires significant government support in the

- form of grants and concessional loans to be commercially viable. A pathway towards commercially viable large scale green ammonia production was identified.
- Worley positively contributed to 'A Hydrogen Roadmap for South Australia', and found the use of green hydrogen for fertilizer, transport and large-scale export had a positive Net Present Value for investment.
