FUTURE OF NATIONAL CABINET

The National Cabinet:

1. Noted the oral update and placemat provided by the Prime Minister on the Future of National Cabinet and reformed arrangements for the architecture of Federal-State relations.

- 2. Agreed:
 - (a) National Cabinet has made an important contribution to minimising the health and economic impacts of COVID-19 and will continue to pursue reforms in the national interest beyond the pandemic
 - (b) National Cabinet's agenda will remain confined to a limited number of issues at any one time to enable it to maintain focus and purpose
 - (c) the initial focus of National Cabinet will be job creation as the economy emerges from the COVID-19 pandemic
 - (d) National Cabinet will be able to establish and task National Cabinet Reform Committees to progress priority reform issues and those Committees will:
 - (i) be led by a Commonwealth representative
 - (ii) report directly to the National Cabinet
 - (e) National Cabinet will continue to engage directly with experts relevant to the issue being considered, including existing Expert Advisory Groups such as the Australian Health Protection Principal Committee and Heads of Treasuries and additional groups as appropriate

- (f) National Cabinet will continue as a Federal Cabinet Office Policy Committee operating under Cabinet rules, with National Cabinet Reform Committees also operating under Cabinet rules
- (g) the Council on Federal Financial Relations (CFFR) will report to National Cabinet and will:
 - (i) operate under Cabinet rules
 - (ii) take responsibility for managing all Federal-State funding agreements, including National Partnership Agreements (NPAs)
 - (iii) initiate a review of all NPAs with the intent of rationalising and decreasing the number of Agreements
- (h) National Cabinet, together with CFFR and the Australian Local Government Association, will constitute the National Federation Reform Council (the Council), which will:
 - (i) meet annually face-to-face
 - (ii) be able to establish Taskforces to support the Council on priority national federation issues, such as Closing the Gap and Women's Safety
- (i) existing Ministerial Forums and Ministerial Regulatory Councils will be reviewed and rationalised and, if retained, will be expected to resolve issues themselves and not have a direct connection with the National Cabinet
- (j) all NPAs will be transferred to CFFR for management and future funding arrangements attached to issues addressed by Ministerial Forums and Regulatory Councils will be negotiated with and by CFFR
- (k) National Cabinet will:

- (i) continue to meet every two weeks while it manages the impacts of COVID-19
- (ii) shift to monthly meetings at an appropriate time
- (iii) continue to meet via telepresence with at least one face-to-face National Cabinet meeting a year
- (iv) retain discretion to vary these arrangements as required

CORONAVIRUS UPDATE

The National Cabinet:

1. Noted the oral update by the Prime Minister on:

SM20/0266

- (a) progress with negotiations on the National Agreement on Closing the Gap, including the planned consideration of the Agreement by the Joint Council on 3 July 2020 and by First Ministers by the end of July 2020
- (b) the Commonwealth Government's ('the Commonwealth') intention to intervene in forthcoming proceedings in the High Court with respect to state border restrictions contravening s.92 of the Constitution on the basis of the Commonwealth's interest in policy positions that arise from the High Court's interpretation of s.92
- (c) work now under way by the Commonwealth on the future of current economic support arrangements.

2. Agreed:

- (a) the subjects to be covered by first National Cabinet Reform Committees:
 - (i) rural and regional
 - (ii) skills
 - (iii) energy

- (iv) infrastructure and transport
- (v) population and migration
- (vi) health
- (b) to consider the proposed forward agendas for those Committees at the National Cabinet's next meeting.

3. Agreed, consistent with draft letter from the Prime Minister to the Commonwealth Treasurer circulated to States and Territories, that the Council on Federal Financial Relations will be:

- (a) responsible for reform proposals on tax, deregulation and housing
- (b) specifically tasked with preparing:
 - (i) an interim report to the National Cabinet by the end of July 2020 setting out a target number of revised National Partnership Agreements (NPAs) and a proposed plan to achieve that outcome
 - (ii) a detailed plan for the consolidation and rationalisation of NPAs for consideration by the National Cabinet in late August 2020.

4. Noted the oral update by the Chief Medical Officer on the latest epidemiological data, including the very low number of cases of community transmission.

- 5. Reconfirmed that:
 - (a) the national COVID-19 response strategy continues to be based on the objective of suppression
 - (b) while zero cases have been achieved in some jurisdictions for some time, new cases will likely arise under the suppression approach.

6. Agreed Health officials continue to emphasise the suppression objective to reassure the community that new cases are manageable and consistent with the strategy adopted.

- 7. Noted:
 - (a) the Pandemic Health Intelligence Report (PHIP) Issue 2 covering the period 25 May to 7 June 2020, which provided sufficient data to assess the initial impacts of the implementation of Step 1 of the Three Step Framework
 - (b) the updated precedent conditions
 - (c) the updated modelling figures.
- 8. Agreed to publication of the:
 - (a) precedent conditions status table
 - (b) summary version of the measures, metrics and thresholds from the PHIP.

9. Noted the Australian Health Protection Principle Committee (AHHPC) statement on the review of physical distancing and person density restrictions.

10. Agreed the AHPPC provide further advice on the application of the 4sqm density restriction in smaller indoor venues.

11. Noted the update from each jurisdiction on:

- (a) their progress against the Three Step Framework for easing of restrictions
- (b) the likely timing of their move to Step 3 of the Framework
- (c) the likely timing of any changes to their border arrangements (where currently in place)
- (d) the general public mood regarding restrictions following the protests of the past week.

12. Reaffirmed National Cabinet's commitment to having Step 3 of the previously agreed Three Step Framework in place during July 2020.

13. Endorsed the AHPPC principles for safe implementation of Step 3.

14. Agreed the following changes to restrictions in Step 3 of the Framework, based on AHPPC advice:

 (a) indoor gatherings: removal of the 100-person limit on non-essential indoor gatherings but retaining the one person per 4sqm with COVID safe practices

- (b) outdoor cultural and sporting events, including in stadiums:
 - (i) for venues up to 40,000 spectator capacity, events need to be ticketed with seating required and attendance will be able to be limited to no more than 25 per cent capacity
 - (ii) for outdoor venues of more than 40,000 spectator capacity, further advice is to be sought from the AHPPC.

15. Reaffirmed that high-risk venues and-high risk outdoor events such as nightclubs and music festivals (unless conditions required for outdoor cultural and sporting events outlined in paragraph 14 above are met) will not be permitted in Step 3 and will be considered following further advice from medical experts.

16. Noted the oral update by the Prime Minister on:

 \langle

- (a) the work being done by the Commonwealth on a staged approach to the easing of international border restrictions
- (b) progress with the arrangements for the Trans-Tasman Travel Zone
- (c) the need for agreement on National Border Coordination arrangements to manage border and biosecurity risks at Australian air ports.

17. Agreed to work closely and carefully to return international students to Australia on a small scale through a series of controlled pilots, with:

- (a) jurisdictions to work with their higher education institutions on detailed pilot arrangements addressing necessary health, quarantine and funding arrangements
- (b) jurisdictions to work with the Commonwealth on appropriate visa and border entry arrangements for their pilots
- (c) individual jurisdictions meeting the following preconditions:
 - (i) a jurisdiction's internal borders would need to be open to other Australians before international students would be permitted to enter Australia to study in that jurisdiction
 - (ii) a return to on-campus learning for domestic students and international students already in Australia will be required before new international students are allowed.

18. Noted the oral update by the Secretary of the Commonwealth Department of the Treasury on the current economic outlook and labour market challenges.

19. Agreed that infrastructure and deregulation are priorities for economic recovery and to discuss at the National Cabinet's next meeting:

- (a) establishing joint assessment teams for new priority major projects
- (b) moving to a single-touch decision making process for environment approvals under the *Environment Protection and Biodiversity Conservation Act 1999* (Cth)
- (c) setting targets to reduce approval times for building and construction projects
- (d) other regulatory reforms proposed by jurisdictions.

20. Agreed to explore the sharing of data to better target employment and training and other services.

- 21. Noted the publication by the AHPPC of advice on:
 - (a) Use of Masks by the Public in the Community (published on 28 May 2020)
 - (b) Guidance on the use of Personal Protective Equipment (PPE) in Hospitals during the COVID-19 Outbreak (originally published on 14 February 2020 and updated on 27 May 2020).
- 22. Agreed at the next meeting on 26 June 2020:
 - (a) the Secretary of the Commonwealth Department of the Treasury will provide an economic update
 - (b) the Chair of the Productivity Commission will provide a briefing on deregulation.

Oral Update CORONAVIRUS UPDATE SM20/0266

The National Cabinet:

Thanked the Chief Medical Officer (CMO), Professor Brendan Murphy, for 1. his outstanding leadership on the COVID-19 response and wished him well in his new role as Secretary of the Commonwealth Department of Health.

Noted the National Partnership on COVID-19 Response would be updated 2. by the end of September 2020 to:

- (a) cease the public hospital component
- allow private hospitals to opt out of the viability guarantee (b)
- (c) ensure the public health component focuses on the essential ongoing response and recovery needs such as testing and tracing and local surge capacity.
- 3. Noted the oral update by the CMO on the:
 - (a) latest epidemiological data
 - localised outbreaks in Victoria and the health response under way (b)
 - (c) continuing risk of community cases linked to hotel quarantine.

4. Noted the update on the response to recent outbreaks by the Premier of Victoria and the State's appreciation for the support provided by the Commonwealth and other jurisdictions.

5. Agreed that for future localised outbreaks Australian Health Protection Principle Committee (AHPPC) advice on jurisdictional needs be immediately communicated by the CMO to the Prime Minister and relevant First Minister to enable rapid support arrangements to be put in place.

6. Noted the AHPPC statement on hotel quarantine which reconfirmed the need for all incoming travellers to undertake 14 days' quarantine in a hotel and recommended adoption of a consistent national testing strategy for people in hotel quarantine.

7. Noted the AHPPC statement on the review of physical distancing and person density restrictions and agreed, based on that advice, that under Step 3 States and Territories can allow small premises to apply a one person per 2 square metre rule with a COVID-Safe plan in place.

8. Noted the National Cabinet Submission titled Australia's Public Health Capacity and COVID-19 and agreed:

- (a) all States and Territories strengthen a formal surge plan for the public health response workforce and review the structure of public health units to determine whether they meet contemporary needs
- (b) the Commonwealth will progress the national interoperable notifiable disease surveillance system (NINDSS) project and all States and Territories will prioritise the use of interfaces with the NINDSS to help with the rapid sharing of information between jurisdictions
- (c) to establish a national training program for surge workforce (built on existing training programs)
- (d) Departments of Health agree a model and shared costs to better support the Communicable Diseases Network Australia (CDNA) over the longer term
- (e) the National Medical Workforce Strategy Project (being led by the National Medical Workforce Reform Advisory Committee) be asked to consider the Australasian Faculty of Public Health Medicine workforce report and prioritise action to enhance public health physician workforce capacity, including recruitment, retention and training, particularly in communicable diseases

- (f) the AHPPC be asked to consider options for developing a formal public health workforce training program, including a national public health officer and nursing training program
- (g) that Health Ministers further consider how each of the actions in paragraph 8(a) to (f) above can be implemented in each jurisdiction.
- 9. Noted:

- (a) the Pandemic Health Intelligence Plan Report Issue 3 (PHIP Report Issue 3), including the shift in epidemiological thresholds for incidence of COVID-19, community transmission and outbreak reporting, driven by the current activity in Victoria
- (b) the updated modelling figures presented in Appendix One to the PHIP Report – Issue 3
- (c) the updated status of precedent conditions which support planned easing of restrictions.

10. Agreed to the publication of the summary documents for the PHIP Report – Issue 3 and precedent conditions.

11. Agreed the AHPPC will provide advice to National Cabinet on a pathway to reopening the live entertainment sector.

12. Noted the oral update by the Prime Minister on the return of international students and other cohorts, including further preconditions for the commencement of international student pilots, as follows:

- (a) pilots must aim to involve students from a diversity of source countries and use commercial flights if feasible or Commonwealth approved charter flights from a regional hub (initially Singapore or Kuala Lumpur)
- (b) pilots must initially be limited to continuing international students
- (c) all costs associated with travel and quarantine must be borne by the beneficiaries (jurisdictions, institutions or students)
- (d) international students must be responsible for funding their stay in Australia and will not be eligible for Commonwealth financial support
- (e) jurisdictions must manage a 14-day quarantine on arrival.

13. Noted the AHPPC advice on the preconditions for the relaxation of international border restrictions.

14. Noted the oral update by the Secretary of the Commonwealth Department of the Treasury, Dr Steven Kennedy, on the global and national economic outlook, labour market and loan deferrals.

15. Agreed that, with all jurisdictions now developing their Budgets, Heads of Treasuries share information and coordination of fiscal response options to assist States and Territories in aligning measures with and complementing the Commonwealth's measures.

- 16. Noted:
 - (a) Commonwealth deliberations are continuing on the future of the temporary support measures
 - (b) the Prime Minister is seeking the support of Premiers and Chief Ministers for an extension of current temporary flexible industrial relations arrangements to avoid further exacerbating the unemployment risks for part-time employees (in particular young people and women).
- 17. Agreed:
 - (a) the Assistant Minister to the Prime Minister, the Hon Ben Morton MP, would consult with individual jurisdictions on home building approval processes to support timely implementation of the HomeBuilder program
 - (b) to discuss infrastructure approval process reforms at its next meeting.

18. Noted the Commonwealth's appointment of the former Director-General of the Western Australia Department of Premier and Cabinet and former Commonwealth Cabinet Secretary, Mr Peter Conran AM, to lead the National Cabinet Review of COAG Council and Ministerial Forums (the Review), with a view to rationalising them as previously agreed.

19. Agreed the proposed Terms of Reference for the Review, with recommendations to be provided to National Cabinet by September 2020.

20. Noted the update by the Director-General of the Australian Signals Directorate, Ms Rachel Noble, on cyber security and agreed on the importance of all jurisdictions lifting their cyber security capabilities.

- (e) the AHPPC statement on recent outbreaks of COVID-19 in Victoria

- (g) the Australian Federal Police's update on national law and order trends during the pandemic.
- 22. Agreed its next meeting will be on 10 July 2020.

CORONAVIRUS UPDATE

The National Cabinet:

- 1. Noted:
 - the oral updates on the Victorian COVID-19 outbreak and the health (a) response under way by the Victorian Premier and the Commonwealth Chief Medical Officer (CMO)
 - (b) the Victorian Premier's appreciation of the assistance provided by other jurisdictions and their continued commitment to providing as much support as necessary.

2. Noted the proposed Victorian approach to the wearing of masks was consistent with the most recent Australian Health Protection Principal Committee (AHPPC) advice on masks.

Noted community attitudes towards social distancing had relaxed in some 3. jurisdictions and agreed the need for continued public messaging on the importance of social distancing in preventing the spread of COVID-19.

- 4. Noted the oral update by the Acting Chief Medical Officer (CMO) on the:
 - latest epidemiological data and modelling (a)
 - key differences in terms of source and demographics between the (b) current outbreak and the earlier national spike in case numbers

- (c) status of measures in the Pandemic Health Intelligence Plan (including the increasing number of measures no longer within the threshold)
- (d) status of precedent conditions.
- 5. Agreed to the publication of:
 - (a) the update on precedent conditions
 - (b) updated measures, metrics and thresholds in the PHIP Report Issue 4.
- 6. Agreed:

- (a) to reduce the number of incoming international passengers by around half between 12 July and 8 August 2020 and potentially beyond
- (b) a national approach to the management of incoming international passengers (based on jurisdictional quarantine capability and number of incoming passengers) be introduced between 12 July 2020 and 8 August 2020 and potentially beyond
- (c) Australian citizens and permanent residents will continue to be the passenger cohorts that are prioritised for returning to Australia
- (d) the following passenger caps be put in place:
 - (i) Melbourne airport continued suspension of inbound passenger arrivals until further notice
 - (ii) Brisbane airport introduce a cap of 500 arrivals per week (with a cap of 30 passengers per flight with some flexibility) until at least 8 August 2020
 - (iii) Perth airport introduce a cap of 75 arrivals per day (with a cap of 50 passengers per flight with some flexibility) until at least 8 August 2020

with caps also to be agreed between the Commonwealth Government ('the Commonwealth') and the relevant States and Territories for Sydney, Adelaide, Canberra and Darwin airports.

any incoming passenger cap requests must seek to maximise use of existing quarantine capacity and be based on accurate and transparent capacity and capability data and information

- (f) to work towards a consistent model of charging for hotel quarantine, noting that more jurisdictions intended to introduce recovery of quarantine costs
- (g) the movement of critical international air freight must continue during this period.
- 7. Agreed:
 - (a) the AHPPC's Advice of 10 July 2020 on 'Nationwide Review of Hotel Quarantining Arrangements'
 - (b) to a national review of hotel quarantine arrangements, led by Ms Jane Halton AO PSM, informed by the AHPPC requirements for the review and to be completed by the end of July 2020 for future National Cabinet consideration.
- 8. Noted the draft papers on:
 - (a) AHPPC Advice on Localised Outbreaks Thresholds for Movement Restrictions
 - (b) Domestic Border Controls Protocols for Closure
 - (c) Domestic Border Controls Freight Movements.
- 9. Agreed to:

- (a) task the AHPPC with finalising its advice on localised outbreaks, for future National Cabinet consideration
- (b) task the National Coordination Mechanism with further developing its draft protocol for border closures to include practical details on implementation, resourcing and timeframes for establishment of containment rings, for future National Cabinet consideration
- (c) task Transport Ministers to consider the draft freight movement protocol and return to National Cabinet with recommendations that support minimal disruption to freight movements across borders, including options for a national permit system
- (d) the Commonwealth returning to the next National Cabinet meeting with a paper on the potential use of the Biosecurity Act 2015 for responding to localised outbreaks, taking into account its prior use with respect to indigenous communities

(e) the Commonwealth returning to National Cabinet with a proposed Australian Safe Travel Zone proposal that could incorporate the future Trans-Tasman COVID Safe Travel Zone and future international student travel as well as explore the potential for limited international business travel between Australia and other countries where health conditions could allow pre-clearances and agreed travel protocols.

10. Noted the importance of a reformed Vocational Education and Training (VET) sector in supporting Australia's economic recovery from COVID-19, including by reskilling and upskilling out-of-work Australians.

11. Noted the Commonwealth's proposed Draft Heads of Agreement for Skills Reform, which would commit all governments to:

- (a) immediate reforms to improve the quality and relevance of the VET sector
- (b) an approach and priorities for developing a new National Skills Agreement to replace the National Agreement for Skills and Workforce Development.
- 12. Noted:
 - (a) jurisdictions that sign the Heads of Agreement would have the opportunity to partner with the Commonwealth in a JobTrainer Fund
 - (b) the Fund would deliver free or low-fee training places for job seekers and young people in areas of identified skills need based on a list of qualifications and short courses agreed with the National Skills Commissioner
 - (c) the Commonwealth's proposal to contribute up to \$500 million to the Fund in 2020-21, contingent on matched funding from those States and Territories wishing to partner
 - (d) the Fund would be administered through a new National Partnership Agreement, to be finalised by August 2020 by the Council on Federal Financial Relations (CFFR) in consultation with the new National Cabinet Reform Committee on Skills.

13. Agreed to progress the Heads of Agreement through bilateral discussions between the Commonwealth and individual jurisdictions.

14. Noted the presentation by the Chair of the Productivity Commission, Mr Michael Brennan, on priority areas to contribute to the National Deregulation Agenda.

15. Agreed to task Treasurers, through CFFR, to consider the regulatory reform proposals from the Productivity Commission and return with advice on suggested priorities, including detailed proposals, with the first priority being to provide options for extending, either temporarily or permanently, the changes to time-based restrictions currently in place to support the COVID response.

16. Noted:

- (a) the Updated Management and Operational Plan for People With Disability
- (b) the AHPPC Statement on management of health risks related to COVID-19.

17. Noted:

- (a) the oral update by the Prime Minister on the 9 July 2020 announcement on new special visa arrangements for Hong Kong residents already in Australia
- (b) the request to the States and Territories to partner with the Commonwealth in developing approaches to encourage footloose businesses and talented individuals from Hong Kong and other countries to relocate to Australia
- (c) the Commonwealth will organise a briefing for First Ministers by relevant agencies on issues relating to Australia's relationship with China.
- 18. Agreed its next meeting will be on 24 July 2020.

The National Cabinet:

- 1. Noted:
 - (a) the oral update by the Acting Chief Medical Officer (CMO)
 - (b) the Paper titled National Cabinet Update as amended by the CMO with the removal of the final dot point in the Victorian section referring to case follow-up timeframes
 - (c) the Pandemic Health Intelligence Plan (PHIP) thresholds
 - (d) Australian Health Protection Principal Committee (AHPPC) advice on the status of precedent conditions.
- 2. Noted:

- (a) the oral update by the Premier of Victoria on the response to recent coronavirus outbreaks
- (b) the oral update by the Premier of New South Wales on the response to recent coronavirus outbreaks
- (c) oral updates by other Premiers and Chief Ministers.

- 3. Agreed:
 - (a) the AHPPC paper titled COVID-19 Strategic Direction, recommitting to the suppression strategy with a goal of no community transmission
 - (b) to consider in August an updated national health plan which emphasises the importance of integrated health and emergency services responses

 - (iv) State and Territory governments reviewing their occupational licensing and registration requirements to determine core requirements to be established to provide a net benefit to consumers and businesses
 - (v) reviewing information available for workers and businesses on mutual recognition to advise on how the collation and use of information will be improved and shared among regulators to streamline the implementation of a system of automatic mutual recognition licensing that can be sustained and standards continuously improved
