Key Points:

- 1. As requested by your Office, we have prepared documents for your signature to finalise machinery of government arrangements following the recent changes to the Ministry.
 - a. On 30 March 2021, Mr Robert was appointed to administer the Treasury (in addition to the Department of Education, Skills and Employment) in anticipation of responsibility for 'small business' transferring to the Treasury portfolio.
 - b. Your Office has indicated that you are also inclined to agree to Mr Robert's proposal that he be responsible for the DTA in the Prime Minister and Cabinet portfolio (PM&C).
- 2. Once signed by you and the Governor-General in Council, the attached documents would:
 - a. transfer responsibility for small business functions and the associated legislation from the Department of Industry, Science, Energy and Resources to the Department of the Treasury;
 - b. transfer the DTA from the Social Services portfolio to PM&C; and
 - c. amend the Administrative Arrangements Order (AAO) to reflect these machinery changes.
- 3. To enable Mr Robert to oversee the DTA, following transfer to PM&C, he also needs to be appointed to administer PM&C.
 - a. This would also allow Mr Robert to administer public data policy and related matters, within PM&C, as was the case before the Ministry changes on 30 March 2021.
 - b. Once signed by you, the instrument of appointment at <u>Attachment D</u> also needs to be signed by the Governor-General. There is no requirement for a new Oath of Office or swearing-in ceremony.
- 4. Once executed, the documents at Attachment B would also give effect to changes to the mandate of the DTA
- 5. To ensure these matters can be considered at the next Executive Council meeting on 15 April 2021, it is necessary for you to write to the Governor-General seeking permission to lodge papers outside of the usual timeframe. The letter at <u>Attachment G</u> identifies a number of late items for Executive Council consideration on 15 April 2021:
 - a. Amendments to the AAO to reflect machinery of government changes (small business and DTA) and amendments to the Order to identify the Minister responsible for the DTA and specifying its functions, which are the subject of this submission.

Administrative Arrangements Order

The proposed amendments to the Administrative Arrangements Order would give effect to the Prime Minister's decision to transfer responsibility for small business functions to the Department of the Treasury, and the Digital Transformation Agency to the Department of the Prime Minister and Cabinet.

The Administrative Arrangements Order (AAO) stems directly from the *Constitution*. Section 61 of the *Constitution* places the executive power of the Commonwealth in The Queen and provides that it is exercisable by the Governor-General. Section 62 provides for the Executive Council and section 64 provides that the Governor-General may appoint Ministers of State to administer such Departments of State of the Commonwealth as the Governor-General in Council establishes.

The AAO specifies the names of Departments of State, the principal matters they deal with and the legislation administered within each portfolio.

The Minute proposes that the Governor-General make amendments to the AAO made on 18 March 2021 to reflect changes to administrative arrangements recommended by the Prime Minister.

The proposed amendments would transfer small business functions and responsibility for the *Australian Small Business and Family Enterprise Ombudsman Act 2015* from the Department of Industry, Science, Energy and Resources to the Department of the Treasury, and responsibility for the Digital Transformation Agency (DTA) from the Department of Social Services to the Department of the Prime Minister and Cabinet, as proposed by the Prime Minister. The DTA is the subject of another item proposed for Executive Council consideration.

These proposed amendments would provide greater alignment of policy directions and objectives in the Government's agenda.

The Minute recommends that the Order be amended in the form proposed.

Order to identify the Minister responsible for the Digital Transformation Agency, and to Specify Functions for the Digital Transformation Agency

I, General the Honourable David Hurley AC DSC (Retd), Governor-General of the Commonwealth of Australia, acting with the advice of the Federal Executive Council and under section 65 of the *Public Service Act 1999*, amend the Order to establish the Digital Transformation Agency as an Executive Agency, made on 12 March 2015 and amended on 21 September 2015, 27 October 2016, 30 August 2018 and 29 May 2019, by omitting paragraphs (d) and (e) of that Order and substituting the following paragraphs:

- (d) identify the Minister for Employment, Workforce, Skills, Small and Family Business as the Minister responsible for the Executive Agency; and
- (e) specify that the functions of the Digital Transformation Agency be as follows:
 - i. provide strategic and policy leadership on whole of government and shared Information and Communication Technology (ICT) investments and digital service delivery;
 - ii. develop, deliver and monitor whole of government strategies, policies and standards for digital and ICT investments, including ICT procurement;
 - iii. manage strategic coordination and oversight functions for digital and ICT investments across the project life cycle, including providing advice on whole of government reuse opportunities;
 - iv. manage whole of government digital procurement to simplify processes for government agencies, reduce costs and generate reuse opportunities;
 - v. provide advice to the Minister on whole of government and shared digital and ICT investment proposals; and
 - vi. undertake other relevant tasks as the Minister may require from time to time.

Paragraph (d) in this Order will commence on the date of Gazettal.

Paragraph (e) in this Order will commence on 1 July 2021.

EXPLANATORY MEMORANDUM

Minute No. of 2021 – Prime Minister

Subject - Public Service Act 1999

Order to identify the Minister for Employment, Workforce, Skills, Small and Family Business as the Minister responsible for the Digital

Transformation Agency and to specify the functions of the Digital

Transformation Agency

The proposed instrument would identify the Minister for Employment, Workforce, Skills, Small and Family Business as the Minister responsible for the Digital Transformation Agency (DTA) and specify the functions of the DTA.

Section 65 of the *Public Service Act 1999* (the Act) provides for the establishment of an Executive Agency. Under paragraph 65(1)(c) of the Act, the Governor-General may identify the Minister who is responsible for an Executive Agency by Order in the *Gazette*.

Subsection 33(3) of the *Acts Interpretation Act 1901* provides that where an Act confers a power to make, grant or issue any instrument of a legislative or administrative character the power shall be construed as including a power exercisable in the like manner to repeal, rescind, revoke, amend, or vary any such instrument.

The DTA, originally named the Digital Transformation Organisation (DTO), was established as an Executive Agency by an Order in Council on 12 March 2015, to take effect on 1 July 2015. That Order identified the Minister for Communications as the Minister responsible. On 21 September 2015, the Minister responsible was changed to the Prime Minister. On 27 October 2016, the Order was amended to rename the DTO to the DTA and specify functions of the DTA. On 30 August 2018, the Minister responsible became the Minister for Human Services and Digital Transformation, with the DTA remaining in the Prime Minister and Cabinet portfolio. On 29 May 2019, the Minister responsible was changed to the Minister for Government Services, and the DTA moved to the Social Services portfolio.

The purpose of the Minute is to recommend that the Minister responsible for DTA be updated to reflect the current responsible Minister, the Minister for Employment, Workforce, Skills, Small and Family Business. The Order proposes that the change to the responsible Minister for the DTA will commence on the date of gazettal.

The Minute also recommends that the functions of the DTA be amended to reflect current Government priorities for the DTA's role in whole of government and shared Information and Communication Technology (ICT) investments and digital service delivery, and on other related matters. The Order proposes that these amended functions will commence on 1 July 2021.

It is proposed that all other aspects of the Order as established and amended continue unchanged. The Minute recommends that the Order be made in the form proposed.


