





- The Australian Government supported the joint Queensland Government and Brisbane City Council bid to host the 2032 Games.
  - Queensland's position in developing its bid to host the 2032 Games has been that delivery will only be possible with full support from three levels of government.
  - Each level of government has given high level commitments to the International Olympic Committee (IOC) to support the bid. \$ 47C

• Since the IOC announced in July 2021 that Brisbane would host the 2032 Games, officials have been negotiating an intergovernmental agreement (Games IGA) to set out funding, governance and delivery arrangements. The IGA has not been settled or signed.

3. To progress Brisbane's candidature for the 2032 Games (the candidature), all three levels of Australian government must confirm their support through a series of guarantees and undertakings to the IOC by 26 April 2021. The Premier – on behalf of the Queensland Government – must provide the IOC with guarantees and undertakings in relation to the delivery and financing of venue and transport infrastructure and legacy programs (amongst other guarantees).

On 16 April, following a letter from Minister Colbeck, the Queensland Minister for Sport, the Hon Stirling Hinchliffe MP, executed a schedule to the National Partnership for Streamlined Agreements to facilitate payment of this funding.

Commonwealth Government Guarantees

- 15. Minister Colbeck wrote to you on 19 April 2021 (<u>Attachment G</u>) requesting that you execute operational and financial commitments (Government Guarantees) on behalf of the Commonwealth to support Brisbane's potential hosting of the Games.
  - a. These Government Guarantees cover areas of Commonwealth responsibility such as security, health and safety, tax matters, and visas. A similar process has been used for other major sporting events held in Australia including the 2018 Gold Coast Commonwealth Games and the upcoming FIFA Women's World Cup 2023.
- 16. The Department of Health has consulted extensively on the guarantees at officials' level and, on 15 April 2021, Minister Colbeck wrote to all relevant ministers indicating his intention to ask you to execute the guarantees. No significant issues have been identified.
- 17. We recommend you sign the letter to the IOC provided by Minister Colbeck, enclosed at <u>Attachment B</u>, executing the guarantees. This letter was drafted by the Department of Health in close consultation with the Australian Government Solicitor. Consistent with support for previous major events, it includes an outline of the constitutional and legislative framework within which the Commonwealth commits to deliver the Government Guarantees. The letter will be included with the other candidature documentation submitted to the IOC by the Queensland Government.
- 18. If the bid is successful, further work will be required to understand the full scope and potential costs to the Commonwealth to deliver the Games. \$ 47C

## Background

 Australia entered the 'Targeted Dialogue' phase of the candidature process on 25 February 2021. The response to the IOC's Future Host Questionnaire was submitted on 7 April 2021. Key dates for the candidature in coming months are outlined in the table below.

- a. Under the *Brisbane Olympic and Paralympic Games Arrangements Act 2021* (the OCOG Act), two previous Australian Government Board members, Senator the Hon Richard Colbeck and the Member for Fairfax, Mr Ted O'Brien MP, ceased their roles as a result of the outcome of the 2022 Federal election.
- 2. In a letter dated 2 August 2022, Minister Butler wrote to you proposing the Hon Anika Wells MP, the Minister for Sport (to be nominated as a vice president of the Board) and Mr Graham Perrett MP, the Member for Moreton, replace the previous Australian Government nominees (<u>Attachment D</u>). The Minister also provided the requisite supporting documentation for these nominees.

4. The OCOG Board's gender requirement is that at least 50 per cent of the nominated directors holding office must be women. The gender requirement will be satisfied after these appointments as there will be 9 women, exceeding 50 per cent of the 17 nominated director positions.

#### **Background:**

- 5. The central functions of the OCOG Board are to undertake and facilitate the organisation, conduct, promotion and commercial and financial management of the Games, in accordance with the Olympic Host Contract. A list of OCOG directors is at <u>Attachment E</u>. This list includes Minister Butler's proposed nominees.
- 6. Section 17(1)(i) of the OCOG Act, provides you four nominees to the OCOG Board. Section 26(2)(a) of the OCOG Act requires that one of these directors be a vice president of the Board.
- 7. Minister Wells attended the previous OCOG Board meeting on 3 June 2022, in an observer capacity. The next meeting is scheduled for 7 October 2022.

## <u>There will be a series of scheduled events in both Japan and Australia, with anticipated</u> <u>significant media coverage</u>

- On 21 July 2021, two days before the opening ceremony of the Tokyo 2020 Olympic and Paralympic Games (the Tokyo Games), at the 138<sup>th</sup> IOC Session in Tokyo (the IOC Session), IOC Members are expected to vote on whether Brisbane will host the 2032 Games.
  - The IOC vote is the culmination of the 2032 Games candidature process and follows the IOC Executive Board's decision, on 10 June 2021, to propose Brisbane as host for the 2032 Games. <sup>§ 47C</sup>

- The IOC Session will be **streamed live** and include a final presentation by the Brisbane 2032 delegation (including the QLD Premier and Mr John Coates), followed by the IOC vote, the announcement of the host and a media conference (the IOC has provided a draft run sheet for proceedings in Tokyo at <u>Attachment A</u>).
- The Australian Olympic Committee (AOC) and Paralympics Australia have arranged a **series of Australian-based public events** on 21 July 2021, based at Brisbane's South Bank Live Site, to create anticipation and atmosphere in the lead up to the vote. Post announcement celebrations are also planned.
- We expect these events and the IOC Session to generate **significant media and television coverage**. Key themes of the announcement will focus on celebration, community, legacy and inclusivity. In Australia, domestic media outlets will begin to preview the upcoming IOC vote from early morning on 21 July 2021.

## **Background**

## History of the 2032 Brisbane Candidature

- The Queensland Government announced it would pursue hosting the 2032 Games in December 2019. This followed the release of a feasibility study to assess South East Queensland's ability to successfully host the Olympic Games, which had been commissioned by the Council of Mayors (South East Queensland) and a comprehensive Value Proposition Assessment undertaken by Queensland's 2032 Taskforce.
- You chaired the first meeting of the Olympic Candidature Leadership Group in August 2019. The Commonwealth Government also committed \$10 million in the 2019-20 Mid-Year Economic and Fiscal Outlook to support the 2032 Games candidature.
- In April 2021 you executed Commonwealth Government Guarantees in support of the 2032 Games, and agreed with the Queensland Premier to enter into a bilateral agreement to fund critical infrastructure on a 50/50 basis, with a new jointly-owned and funded

infrastructure agency to be established to manage the infrastructure program associated with the 2032 Games.

• The IOC Executive Board agreed to propose Brisbane as host for the 2032 Games on 10 June 2021. This decision was based on a detailed report by the IOC Future Host Commission which entered 'Targeted Dialogue' with the Brisbane bid for the Games on 25 February 2021, confirming Brisbane as the 'preferred host' for the 2032 Games. This is the first time the new process for selection of the host city has been undertaken by the IOC.

## Expected benefits of the 2032 Games

• A recent, publicly released KPMG Report found that the economic and social benefits of hosting the 2032 Games are estimated to be up to \$8.1 billion for Queensland and \$17.6 billion for Australia.

## Brisbane 2032 delegation

 The official Brisbane 2032 delegation includes Premier Palaszczuk, the Lord Mayor of Brisbane, Councillor Schrinner, Minister Colbeck, the Chief Executive Officer of Brisbane City Council, Mr Colin Jensen, Ms Kerry Petersen PSM from Queensland DPC, and Mr Patrick Clancy from Minister Colbeck's office. While you are participating virtually, you are still considered a member of the official Brisbane 2032 delegation.

## **Background:**

## 2032 Olympic Candidature

- The Australian Government previously committed up to \$10 million in support of Queensland's candidature. On 12 April 2021, Minister Colbeck wrote to the Queensland Minister for Sport, the Hon Stirling Hinchliffe MP, seeking his agreement to a Schedule to the National Partnership for Streamlined Agreements (Brisbane, Queensland 2032 Olympic and Paralympic Games Candidature), to deliver on this commitment.
  - The Premier's letter of 13 April 2021 seeks payment of the full \$10 million. The Schedule in Minister Colbeck's letter proposes that \$4.47m is paid on the signing of the Schedule and the remaining up to \$5.53 million is paid on 15 May 2021.
- The initial submission of the Future Host Questionnaire or 'bid' book was submitted to the International Olympic Committee (IOC) on 7 April 2021.
- We expect the Minister for Sport, Senator the Hon Richard Colbeck, will write to you shortly seeking your in-principle agreement to guarantees of Commonwealth support for the Games (covering support measures such as security, tax and visas), following consultation with relevant ministers.
- Australia entered the 'Targeted Dialogue' phase of the candidature process, on 25 February 2021, following a formal recommendation by the IOC Future Host Commission to the IOC Executive Board.

- 1. Following discussion between you, Secretary Gaetjens and Secretary Atkinson on 4 August 2021, regarding the options for Games governance arrangements (<u>Attachment E</u> refers), you made the following key decisions:
  - a. The Minister for Sport, Senator the Hon Richard Colbeck, will continue to lead the Commonwealth's overall involvement in non-infrastructure components of the Games, including the Olympic and Paralympic Games (OCOG) and Olympic and Paralympic Coordination Authority (OPCA).

- b. The Minister for Communications, Urban Infrastructure, Cities and the Arts, the Hon Paul Fletcher MP, will lead work for the Commonwealth on non-transport related critical infrastructure associated with the Games through the establishment of a new, independent public entity jointly owned by the Queensland and Commonwealth governments.
  - i. The new entity's role will be to make decisions on which infrastructure projects to fund, and contract third parties to deliver these. It would be dually accountable to the State and Commonwealth Parliaments, and funding (either grant or equity) is to be provided by both governments on a 50:50 basis.
  - ii. Minister Fletcher will work closely with the Minister for Finance, Senator the Hon Simon Birmingham, on design of the new entity, and lead negotiations with the Queensland Government on its establishment.
- c. Minister Fletcher will also lead on transport-related critical infrastructure associated with the Games, which will be prioritised and progressed through the existing National Partnership Agreement on Land Transport Infrastructure Projects with Queensland.

- e. The Member for Fairfax, Mr Ted O'Brien MP, will continue to be involved in supporting the Commonwealth's interests in the Games through a Special Envoy role. We propose this could include: supporting Minister Colbeck and Minister Fletcher in performing their roles; and performing a business/community/civil society liaison role, reporting to you, to ensure the Commonwealth retains an ongoing dialogue with and understanding of the interests of these key parts of the Queensland community.
- 2. To implement these decisions with a coherent, whole of government approach, we recommend the Commonwealth enter into an overarching Intergovernmental Agreement (IGA) with the Queensland Government. The IGA would not be legally binding, but would set out each party's roles and responsibilities on all aspects of the Games, include operating principles, governance and dispute resolution clauses, and contain specific schedules setting out arrangements for the transport and non-transport critical infrastructure components.


- 3. The letter at <u>Attachment A</u> asks Minister Colbeck to lead on development of the overarching IGA, through negotiations with the Queensland Government. This accords with your expectation that Minister Colbeck will continue to lead on all non-infrastructure components of the Games.
- 4. The IGA should include high level operating principles, and set out expectations on the role of the Commonwealth and Queensland in relation to the Games, OCOG and OPCA. This should include the composition of boards, how these bodies would work together, and how they would interact with a third, independent entity delivering the non-transport infrastructure components of the Games.
- 5. The IGA should also set out a common understanding of the roles of the International Olympic Committee, the Australian Olympic Committee, Paralympics Australia and any other key stakeholders.
- 6. A draft IGA would need to be agreed s 47E(d) before Minister Colbeck finalises this with the Queensland Government. The IGA would not include provisions on specific funding contributions; this would be agreed in a separate funding agreement.

- 11. Noting your preference for Mr Ted O'Brien MP to remain involved in representing the Commonwealth's interests in the Games through a Special Envoy role, the letter at <u>Attachment C</u> thanks Mr O'Brien for his efforts to date, and appoints him as the Commonwealth Government's Special Envoy for the 2032 Brisbane Olympic and Paralympic Games.
- 12. The scope of Mr O'Brien's role as Special Envoy would be primarily to support Minister Colbeck and Minister Fletcher in performing their roles; as well as undertaking business/community/civil society liaison, reporting to you, to ensure the Commonwealth retains an ongoing dialogue with and understanding of the interests of these key parts of the Queensland community.
- 13. As you would be aware, Special Envoys are not ministerial appointments and are not vested with any executive powers or functions, but are well-suited to liaison and communication roles.
- 14. Any support for Mr O'Brien in his role as Special Envoy that is needed from within the Department of Health and DITRDC, will be provided through the offices of Minister Colbeck and Minister Fletcher.

17. A high level governance diagram at <u>Attachment G</u> outlines proposed transitional governance arrangements to support immediate work required by December 2021, as well as establishment phase governance from 2022 onwards.

- a. During the transition phase, existing bodies previously associated with the candidature would be leveraged to support the establishment of the OCOG. However, there would also be a clearer leadership role for Minister Colbeck and Minister Fletcher to negotiate an IGA, along with their Queensland counterparts. Minister Colbeck and Minister Fletcher's negotiations would be supported through officials-level groups.
- b. During the establishment phase, these transition-focused bodies would be replaced by the OCOG, OPCA and the new infrastructure entity. Through IGA negotiations, it may be determined that further arrangements are needed to support ongoing communication and collaboration between different levels of government and relevant stakeholders during this phase, also.

As per section 17(1)(i) of the OCOG Act, you can nominate up to four persons to OCOG's Board as nominees of the Prime Minister.

- 5. Under the OCOG Act, at least 50 per cent of nominated directors must be women. With the addition of the five independent directors, there will be 8 nominated directors who are men and 8 nominated directors who are women. This means the gender requirement is currently satisfied. A summary of OCOG directors, including a gender breakdown, is at <u>Attachment E</u>.
- 6. It's important to note that there is one remaining nominated director to be confirmed on the OCOG Board, which is the Australian Olympic Committee's (AOC) nomination of their president or honorary life president. The AOC has not nominated their current president John Coates AC as he is retiring. Mr Coates is expected to be replaced at the elections for president at AOC's Annual General Meeting on 30 April 2022.
  - a. If the next AOC president is male and the AOC nominate their president, then the gender requirement for nominated directors will not be satisfied.

b. Mr Coates will continue as an OCOG director by virtue of being a Vice President of the International Olympic Committee from Australia (an ex-officio director role)
