In 1993 and 1994, although there was no reason to believe that the event was imminent, just as there is not now, I had some discussions with some of your colleagues in PM &C concerning possible funeral arrangements for my father, Gough Whitlam. I was asked to keep in touch and I have neglected to do so. The purpose of this letter is to bring the Department up to date.

In summary, the family is planning a private cremation and a secular memorial service. The preferred venue for the memorial service is Sydney Town Hall, and we have in mind four or five speakers with their contributions interspersed by some video material and fine music. We have access to video records from the Whitlam Institute and elsewhere, and quite a bit of work has been done on possible music items, including some suggestions from our father; his only other suggestion has been an RAAF fly past. ("John Gorton got a fly past.")

I hope this is helpful. Please fell free to contact me by telephone or e-mail if you wish to have anything clarified.
