These responsibilities include:

- Progress Australia's strategic priorities in implementing CRPD with other states parties, the UN and civil society attending COSP17.
- Delivering Australia's National statement on Australia's progress towards the realisation of disability rights.
- Delivering joint country statements, on the advice of the Department of Foreign Affairs and Trade as they become available.
- Leading bilateral meetings with like-minded countries.
- Meetings with the UN in relation to COSP17 and the CRDP.
- Meetings with key stakeholders relating to portfolio responsibilities.
- Attending an Australian Welcome Reception and other relevant side events, meetings, and official functions.

I understand you requested some further information in a conversation with Robyn Shannon earlier today to understand the urgency in relation to formal approval sought from the Prime Minister for international travel for the Honourable Bill Shorten MP, and two ministerial staff ( $\frac{22(1)(a)(ii)}{a}$ ) and  $\frac{22(1)(a)(ii)}{a}$ ) as part of the Australian Government Delegation.

Australia ratified the CRPD in 2008 and participates in the United Nations Conference of States Parties (COSP) to the Convention on the Rights of Persons with Disabilities (CRPD) each year, to meet and consider matters about implementation of the CRPD, with other signatories to the CRPD. The COSP takes place annually in June at the UN Headquarters in New York, with the 17<sup>th</sup> Session of COSP scheduled from 11 to 13 June 2024.

States Parties (Governments) are able to present a National Statement on behalf of their country at COSP and may also present joint country statements where opportunities are presented. Consistent with past practice, it is

proposed that Minister Shorten present a National Statement at this COSP, with the UN requiring speakers to be inscribed by no later than **15 May 2024**.

Prior to Speakers being inscribed to the UN portal, formal approval is required of the Australian Government Delegation. As such, we would be grateful for your assistance in facilitating approval this week.

In addition to attendance at COSP and associated UN requirements, prompt approval will enable meetings to be progressed with international ministerial counterparts with appropriate lead time.

To maximise the visit to New York, a significant number of bilateral meetings and attendance at side events are also facilitated around COSP commitments. Due to scheduling pressures, consistent with last year where the Chief of Staff and Senior Media Advisor accompanied Minister Rishworth, it is proposed that Minister Shorten is also supported by two ministerial officers, his Chief of Staff and Senior Advisor.

- The purpose of the visit would be for Minister Shorten to represent Australia as the Head of Delegation at the United Nations (UN) 17th Session of the Conference of States Parties (COSP17) to the Convention on the Rights of Persons with Disabilities (CRPD).
- COSP17 is being held at the UN Headquarters in New York. The overarching theme is 'Rethinking disability inclusion in the current international juncture and ahead of the Summit to the Future'.

- 7. The 'Ministerial International Travel Request Form' specifies that the number of staff expected to routinely accompany a Minister on international travel is one.
  - a. Minister Shorten requests to be accompanied by two staff, his Chief of Staff and a NDIS senior adviser/policy lead for support given the disability-themed content of the trip.
  - b. The Department of the Prime Minister and Cabinet (PM&C) does not support two policy advisers travelling as the program, as presented, is not significantly complex to justify Minister Shorten being accompanied by two staff. Minister Shorten would also receive assistance from Australia's diplomatic representatives in New York during his visit.
  - c. We note that the Hon Amanda Rishworth, Minister for Social Services travelled to the USA in June 2023 to attend COSP16 and we recommended that Minister Rishworth be accompanied by one staff member. However, as Acting Prime Minister, the Hon Richard Marles MP, agreed to Minister Rishworth being accompanied by two staff given the size of the accompanying Australian delegation (MS23-000484 refers). A similar sized Australian delegation is expected to travel to COSP17.

I refer to your correspondence dated 18 April 2024 seeking approval for the Minister for the National Disability Insurance Scheme and Minister for Government Services, the Hon Bill Shorten MP, to travel to the USA from 8 June to 15 June 2024.

The Prime Minister has asked me to convey to you that:

- The Prime Minister has approved Minister Shorten's travel to the USA from 8 June to 15 June 2024, accompanied by one adviser.
- The current program does not have any engagements scheduled for Sunday 9 June.
   To maintain value for money expectations the travel should be shortened to avoid the rest day or ministerial-level engagements programed for that day.
- Minister Shorten and the advisers travelling are required to participate in a security briefing prior to departure, which is to be organised by your Department. Your Department is required to coordinate this briefing with relevant security agencies.
- It is noted that the Minister for Small Business and Minister for Housing, the Hon
  Julie Collins MP, will act as the Minister for the National Disability Insurance Scheme
  and Minister for Government Services while Minister Shorten is absent.
