Handling note: questions on other government funding arrangements with China Matters should be referred to those respective departments.

- PM&C and other departments have funded China Matters to conduct research on national security and foreign policy matters.
 - PM&C's funding agreement with China Matters ended on 30 June 2020.
 - This has been a difficult year with new pressures on our fiscal position. In view of these budget pressures, PM&C did not enter a new funding arrangement with China Matters.
 - Any decision on future funding would be subject to PM&C's financial position and the Government's policy priorities.

If pressed on funding coordination among agencies:


- A number of government departments, including PM&C, fund a variety of non-government bodies (including China Matters) to conduct research on national security and foreign policy matters.

Deductable Gift Recipient status

- As part of the 2020-21 Budget, the Government announced it would no longer proceed with specifically listing China Matters Limited as a Deductable Gift Recipient (DGR) from 1 July 2019 to 30 June 2024.
 - As is usual practice, PM&C worked with the Treasury to provide advice to the Government as part of the budget process each year.
 - Decisions on these matters are made by the Expenditure Review Committee of Cabinet.
