

RE: Certainty for Macquarie Harbour Salmon Aquaculture Industry

We write as the Chief Executives of Tasmania's three salmon companies - Petuna Seafood, Tassal Group and JBS Huon Aquaculture – who all farm in Macquarie Harbour, on Tasmania's West Coast.

We thank-you for your visit to Strahan on the weekend and acknowledge your ongoing public support for the salmon farming industry and those whose livelihoods depend on it.

As you saw first-hand at the community Christmas event, keeping local jobs on the West Coast is critical to these communities and the present uncertainty is impacting not only our employees but local businesses, schools and wider economic activity across the region.

As you are aware, the Department of Climate Change, Energy, Environment and Water (DCCEEW) is still considering requests for the reconsideration of the 2012 decision that our operations in Macquarie Harbour are not a Controlled Action if undertaken in a particular manner (NCA/PM) and is still preparing advice and recommendations to the Minister for the Environment and Water (Minister).

Together, as an industry, we are asking you as Prime Minister to help end this uncertainty and to support the replacement of the current NCA/PM decision with an updated and contemporary NCA/PM decision. This is the right outcome on the basis of science and importantly will end the uncertainty for families and businesses across North-West Tasmania.

An updated NCA-PM for Operations in Macquarie Harbour

We propose that a new NCA-PM decision could include requirements for operators in Macquarie Harbour to produce:

- 1. Dissolved oxygen consumption reports to measure how the dissolved oxygen consumption is changing over time in the Harbour;
- 2. A dissolved oxygen mitigation plan to outline how the dissolved oxygen consumption generated can be offset or reduced by operators; and
- 3. A continuous water quality monitoring plan, which requires operators to measure changes to water quality to monitor the effectiveness of the mitigation plan.

Requiring the operators to adhere to these additional conditions would modernise and upgrade the conditions imposed by the 2012 decision by then Minister for the Environment, Tony Burke MP, and







address concerns raised recently about the alleged impact of our operations on dissolved oxygen levels within the harbour and the environment for the Maugean Skate.

Importantly, these additional stringent conditions would align the EPBC Act decision with the conditions now imposed on operations by the Tasmanian Environment Protection Authority (Tasmanian EPA) through its environmental licence conditioning (renewed in November 2023).

We wrote to Minister Plibersek on 6 November 2024, proposing this pathway forward and asked that the Minister consider all information put forward by Salmon Tasmania, the Tasmanian Government and the Tasmanian EPA, which ultimately supports reaching a conclusion that a NCA-PM decision remains the appropriate authorisation for Macquarie Harbour. We are yet to receive a response to this correspondence.

No grounds for revoking the existing NCA/PM

Our position is supported by the fact the environmental licencing requirements now imposed by the Tasmanian EPA are working; with scientists finding a clear trend of improving oxygen levels in Macquarie Harbour since their imposition. As a result, two thirds of Macquarie Harbour has now returned to the same oxygenation levels recorded between 1993-2010 and Tasmanian EPA monitoring data shows the conditions in the Harbour are now at their best level in over a decade. Scientific evidence has also shown the Maugean Skate juvenile population has stabilised.

These positive developments will also benefit from the funding your Government recently committed to future oxygenation efforts in the Harbour that builds upon the extensive work our companies are also undertaking through the Macquarie Harbour Oxygenation Project.

It is also important to recognise through the steps voluntarily taken by industry and under the regulatory direction of the Tasmanian EPA, permitted salmon aquaculture production levels in the harbour are *less* today than when our NCA/PM approval was granted in 2012.

The alternative to what we are proposing is for the Minister to take the extraordinary step of replacing our existing 2012 NCA/PM decision and making a decision that our operations within the Harbour are a 'Controlled Action' (CA).

This would require our companies to initiate the long, uncertain and highly contentious process to seek EPBC Act approval if we wish to remain operating in the Harbour. Further, the operation of the EPBC Act would require us to immediately cease all operations that are part of the CA, while the assessment and approval process is being undertaken. A process which will take years.

There have also been media reports the Federal Government is still exploring the potential for the Minister to initiate her powers to issue a 'National Interest Exemption' to enable the industry to continue to farm and manage our livestock at some level while seeking EPBC Act approval.

We must be clear - we do not see these options as a genuine solution for the industry or the community. Indeed, they pose considerable risk to both the industry and the Government and will not provide the certainty local communities are seeking.

A CA decision – even with a National Interest Exemption – will mean a protracted period of ongoing uncertainty and debate around our operations in Macquarie Harbour. They are outcomes that will be







quickly weaponised by well-funded and aggressive activist organisations pressuring our consumers, retailers and certification bodies. They will also inevitably use that decision as an opportunity to spread further misinformation and cast doubt in the community about the sustainability of our operations in other parts of Tasmania. Such decisions would also establish a major precedent that will undermine investment confidence in our industry, and other established industries across Australia relying on EPBC Act approvals or decisions.

Government Support Must Translate into Action and Certainty for the West Coast

We are encouraged by the bi-partisan support our industry has received from the Tasmanian Government and Dean Winter MP, Leader of the Opposition, and federally from you, many of your colleagues and the Coalition. This issue should not be about politics, it is about making rational decisions based on clear science and striking a balance between environmental management and supporting the jobs and industries of regional communities.

But this support must translate into action and certainty for hundreds of families worried about their livelihoods.

The reconsideration request process commenced over 12 months ago. With an election looming, we are calling on you as Prime Minister to urgently back West Coast communities and families you have met recently, by supporting an updated NCA-PM decision.

We would welcome the opportunity to further discuss this with you or your representatives in the coming days.



Again, we appreciate your ongoing support for the industry and look forward to discussing the proposed Bill with you or your representatives soon.


