# Submission to the Commonwealth Government COVID-19 Response Inquiry

We welcome the Inquiry's review of the Commonwealth Government's response to the COVID-19 pandemic.

## Legal considerations

The mandating of COVID-19 vaccines was in breach of Section 51(xxiiia) of the Constitution of Australia<sup>1</sup>. Wong v Commonwealth (2009) supports this point; "Mandatory jabs and bans on the unvaccinated? Try getting that past the High Court":

## Future responses

Future responses to a pandemic must take into account the following:

### Excess deaths

Australia now has an unusually high rate of excess deaths, yet the Senate voted to not look into the reasons for this.<sup>3</sup> A future response to a pandemic cannot be effective unless current excess deaths are investigated. Medical professionals are taking interest in this issue.<sup>4</sup>

#### Masks

The report "Do physical measures such as hand-washing or wearing masks stop or slow down the spread of respiratory viruses?" ( 30 January 2023) states that the wearing of masks and N95/P2 respirators may make little to no difference in how many people caught a flu-like illness/COVID-like illness.

#### Lockdowns

Signatories to the Great Barrington Declaration<sup>6</sup> stated<sup>7</sup>:

Current lockdown policies are producing devastating effects on short and long-term public health. The results (to name a few) include lower childhood vaccination rates, worsening cardiovascular disease outcomes, fewer cancer screenings and deteriorating mental health – leading to greater excess mortality in years to come, with the working class and younger

members of society carrying the heaviest burden. Keeping students out of school is a grave injustice.

Furthermore, the closure of Catholic churches (among other religious places of worship) was also a grave injustice against human rights.<sup>8</sup>

### Recommendation

Commonwealth Government COVID-19 Response Inquiry should include the actions taken unilaterally by state and territory governments. The states/territories must be held accountable for the severity of lockdowns, border closures, coercion to take vaccines, mandates, job losses, business closures, family separations (to name a few). Human Rights Commissioner made comments about the decision to exclude actions taken unilaterally by state and territory governments from the inquiry in a media release (21 September, 2023).

The Catholic Women's League of Australia would be prepared to attend a hearing, and requests to be called to speak.
